## **Release of Liability Waiver**

The participant named below and any minor or individual legally incapable of executing this document for whom I am signing (referred to as “I” or “me”) desires to use the services and premises of Alpha International Outfitters, a Wyoming Incorporated LLC, to engage in events, activities, transportation, tours, excursions and hunting activities organized, managed by or run by the Outfitter, including, without limitation, hunting activities- including all the variations- Spot and stalk, hunting from blinds, hunting from elevated stands, participation in Monteria’ hunts, bird hunting all fishing activities occurring in a foreign country (i.e.. Spain) or in the United States. As lawful consideration for being permitted by the Outfitter to be on the leased property or subcontracted property and engage in the Outfitter Activities, I agree to all the terms and conditions set forth in this agreement.

1. **Release and Waiver of Claims-** The client is fully aware and understands that the Outfitter activities involve many risks, dangers, and hazards, including but not limited to the risk of property damage, serious injury, disability (including permanent disability), or death. This includes, but is not limited to: hazards related to travelling by motorized vehicle, on horseback, bicycle, electric bike, and by boats; hazards of hunting carrying and being in possession of firearms and ammunition; hazards of being in proximity of other hunters with firearms, hazards of being exposed to potentially dangerous game, hazards of being exposed to the elements of nature; hazards of being in areas where hunters are likely to be present; hazards of being and travelling in remote wilderness areas and hazards arising from accidents, acts of God, illness and forces of nature.
  
2. **Indemnification and Hold Harmless-** By signing this document the client, acknowledges the risks, dangers, and hazards involved in the Outfitter Activities. I freely and voluntarily assume all risks that I (or the person I am signing this document on behalf of) may suffer from the Outfitter Activities, and further acknowledge that such risks could lead to property damage, injury, illness, disability (including permanent disability), or death, whether caused by the actions, omissions, or negligence of myself or others, including, but not limited to, the Outfitter owners, directors, officers, employees, volunteers, agents, representatives, instructors, guides/tail-guides, trip leaders, contractors, subcontractors, successors and assigns, and host locations I understand that this includes negligence on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers, and hazards of the Outfitter Activities. I freely accept and fully assume all such risks, dangers and hazards, and the possibility of injury, illness, disability (including permanent disability), death, or property damage related to the Outfitter Activities.
  
3. **Indemnify and Hold Harmless-** By signing this document the client, releases the Outfitter from any loss, liability, bodily injury, property damage or loss of cost, (including all attorney’s fees and hospital and medical expenses) incurred by the client arising from above listed Outfitter activities conducted by employees, family members, subcontractors, vendors, landowners, minors or others clients of Alpha International Outfitters LLC.

4. **Use of Image and Likeness** - I agree to allow Alpha International Outfitters the use of image, photos, videos and likeness to post on social media and the company website as well as printed materials. These posts can show client engaged in all the activities Alpha International Outfitter LLC engages, hunting, fishing, scouting, hiking, touring, etc.

- 1) I am in good health, in proper physical condition, and do not have any medical or other conditions that would impair my ability to participate in the Outfitter Activities;
  - 2) I will comply with all relevant federal, and provincial laws, regulations, or codes that client and Outfitter subject to in the country and state activities are occurring and
  - 3) I will comply with all directions, instructions, and other safety measures of the Outfitter while on the Premises and during my participation in Outfitter Activities.
6. I have read and understand this document, and by signing this document voluntarily I am agreeing to abide by these terms. I am aware that I am waiving certain legal rights which I or my heirs, executors, administrators, assigns, representatives, and next-of-kin may have against the Releasees.
